MUSIC MINISTRY

Music ministry continues to explore a wide range of genres and styles for worship, including folk, classical, Taizé, spirituals, gospel and contemporary praise music with both organ and piano accompaniment.

We hosted a carol-sing during the annual Advent Open House, which included adults and children alike for a fun, festive music experience! This is such a special moment for everyone to sing together, regardless of whether they are in an ensemble or not!

We hosted Wednesdays at Wallingford involving music, like the Staff Musical Revue where Leslie, Taylor, François, Nathan and Lee performed. We also hosted the Farewell Concert for Francois and Cyndi in October, featuring our very own choir.

Our “Concerts for a Cause” series continues to bring varied talented musicians to WPC to perform benefit concerts. In February we hosted four professional singers to perform the Brahms "Liebeslieder" as a benefit for PFLAG Media, an organization that supports and advocates for members of the LGBTQ+ community and those who love them. In April our Chancel Choir and other volunteer singers from the community performed Vivaldi's Gloria and other choral works in support of Chester Eastside.

CHILDREN'S MINISTRY

Our children's ministry focuses on bringing programs to our children ages 0-12 and offers Sprouts Nights (K-5th), Weekly Sunday School (12months – 12yo), Children's Choir (all ages), and two pageants per year.

Our yearly Christmas Pageant was a success, as we had 36 little ones perform "The Fourth Wise Man!" We also have been blessed with many new families participating in Sunday worship, Sunday School, and Sprouts!

YOUTH AND YOUNG ADULTS

This year we've seen a boom in youth group, and we are so pleased that our youth are not only coming to the events, but also volunteering as ushers, AV assistants, pageant co-directors, and more! A big highlight for us was our Christmas party when old friends and new friends gathered to celebrate the holiday season!

CHILDREN'S MUSIC MINISTRY

- Our children continue to have fun and informal music opportunities once a month during "Kids' Cafe", where they can sing and play songs with Miss Lee and Pastor Taylor.
- The Chapel Choir has performed several times in 2025, with a featured performance as the "music for meditation" during worship.
- We kicked off Holy week with a Palm Sunday Pageant, featuring costumes, scenery, props, dramatic reading and music!
- The third Sunday of Advent featured our traditional children's Christmas Pageant, during which the children sang songs with the congregation and a featured anthem as the Chapel Choir. We had a record-breaking number of participants this year and sang an anthem in two parts!
- Our children led the way during our Advent Open House carol-sing, picking their favorite carols to sing and competing for the most emphatic "five golden rings" during "The Twelve Days of Christmas"! It was a blast, thanks to the energy and talent of our wonderful kids!
- Our Chapel Ringers, a bell choir for our middle-school aged children, continues to grow and perform for Easter and Christmas, both at the pageant and on Christmas Eve.

ADULT MUSIC MINISTRY

- Our adult music ministry has seen growth and new membership in every ensemble, including Chancel Choir, Bell Choir and Wallingford Winds! We are always so happy to welcome new members and would like to remind everyone that you can join at any time, no need to wait for September!
- Wallingford Winds continued to play for special services at WPC, including Easter, Music Appreciation Sunday, Transfiguration, and Christmas Eve.
 - Our Bell Choir and Chancel Choir performed regularly throughout the program year in a variety of styles and genres, often featuring solos by our wonderful staff singers, Meghan Cakalli (soprano), Corinna Bueckner (alto) and Tyler Gibson (tenor). Corinna resigned as of the fall of 2025 and we wish her all the best as she focuses on grad school auditions!
 - During the summer, we held a pick-up choir that met the morning of worship to put together special anthems.
 - We had fantastic soloists and small groups perform anthems over the summer, and continued this throughout the program year, allowing our wonderful musicians to shine in a variety of contexts and settings.
 - Our adult musicians have continued the tradition of celebrating all their hard work with two "musician parties", one in June at Iron Hill Brewery and one in December at the church. With all the time, energy, devotion and talent our volunteer musicians contribute to our ministry, they deserve to kick back and enjoy some fellowship together!

TRUSTEES

The Trustees are responsible for maintenance and upkeep of the Church building, both Manses and all the grounds to ensure that they are safe for use, meet the needs of the many individuals and groups that use them throughout the year, and present a positive image within the surrounding community. Routine maintenance of the building structures and their grounds along with all utility systems, mechanical equipment, finishes, and fixtures is ongoing, along with larger repair projects and planned enhancements as needed to meet anticipated future needs. This work is done by members of the Trustees and volunteers from the congregation, often behind the scenes, who donate their time and expertise, and, for larger projects or where specialized skills or services are needed, by outside contractors. Valuable assistance is also provided by members and leaders of our several Scouting troops during our Spring and Fall grounds-cleanup days.

Some significant projects completed during 2025 include: Repair and repainting of walls and ceiling in the hallway and stairwell between the Sanctuary and Fellowship Hall and repainting of the exterior wood fascia trim of the Sanctuary, the portico over the Youth Room exterior door, and the metal fire escape from the Fellowship Hall; cleaning and flushing of all downspouts, window well drains, and courtyard inlet drains around the church building to minimize future basement water infiltration; installation of Carbon monoxide detectors and electronic monitoring system; set up ongoing monitoring of rodent and insect infiltration activity in church building with as-needed extermination; repair of failed ceiling section in rear of Sanctuary; preparation of A Manse for anticipated change of occupancy, included several projects. Both the Spring and Fall grounds clean-up projects were again successful with the critical manpower assist provided by our Scouting organizations.

Non-routine projects requiring attention in 2026 include tree removal and maintenance, replacing a water heater, adding remote timers to thermostats, and repairing the ceiling in the Fellowship Hall. Longer term projects currently under Board consideration include installation of solar roof panels to offset daily electricity demand, and improved accessibility to Fellowship Hall, the Office wing and the Sunday School and nursery co-op areas.

Many thanks to outgoing 2025 Trustees Bruce Clark, Tony Tolomeo, Dave Rudd, Mary Payne for their years of dedicated service, and welcome to incoming Trustees for 2026 Walt Kaminski, Louise Rowland, and Joe Vaccone. With the incoming 2025 Trustees, the size of the Board has been officially reduced from the previous 12 members to 8, while the scope of the Board's responsibility remains the same. Therefore, any member of the congregation (church member or not) who has experience working in areas such as electrical, plumbing, heating or air-conditioning, painting, carpentry, flooring, roofing, woodworking, gardening, etc. and who would be willing to assist by working on a small task from time to time, would be welcome. Please let us know by contacting either a member of the Board or the Church office of your interest.

DEACONS

The Book of Order describes the role of the deacons as “one of compassion, witness, and service” to those who are in distress. The twelve deacons of WPC embrace this calling to directly connect with people within and outside of our congregation.

What are examples of this ministry?

- Deacons collect and distribute the generous donations of WPC and associated groups through our Red Wagons to three food bank programs in the immediate area: Media Food Bank, Chester Eastside, and Foundry Church.
- Our programs of visitation with members, weekly floral distributions noting member life events (birthdays, anniversaries, illnesses, etc.), and provision of meals, rides, and other temporary assistance help members feel seen and included.
- Our Christmas season Giving Tree program for families in our surrounding area and the Angel Tree program to provide gifts to children of incarcerated people are an important outreach effort.
- Two times a year Deacons host an American Red Cross Blood Drive that continues a tradition more than 75 years long.



WORSHIP COUNCIL

The purpose of the Worship Council is to support the Church staff in planning worship services and music ministry.

In addition, the Council coordinates and performs (or arranges for the performance of) many activities that support worship at WPC including:

- The Council sets the Communion schedule to be approved by Session.
- Jenny Miller has arranged for volunteers from the congregation to serve as liturgists to assist in worship services.
- Lin Floyd arranges with Marcus Hook Florists to provide chancel flowers for our Sunday services.
- Barb Demos arranges for the purchase of Poinsettias and Easter plants.
- The Council decorates the Sanctuary and Narthex for Christmas and Easter.
- Judy Kenworthy coordinates volunteers from the congregation to serve as ushers
- The Council prepares and serves coffee hour on a rotating basis with other Councils and Committees.
- Shirley Rudd and Michelle George with support from members of the Christian Ed Council, works to make worship more inclusive to all abilities.
- After many long years of planning and waiting, thanks to the hard work of Joe Vaccone and his team, in the fall of 2025, right before Francois' retirement, our new Audio-visual project was presented to the congregation.
- Sadly, for us, our dear Pastor Francois LaCroix retired in October – fittingly on Reformation Sunday. Though he will be missed, Pastor Taylor Cornelious has taken over the reins and is doing an outstanding job in leading our ever-growing flock.

EDUCATION COUNCIL

ABILITIES INITIATIVE

-Planned and organized WPC's first Day of Service, coordinating with local organizations in need, securing donation partners, and leading product drives and promotion throughout 2025 to prepare for the event.

STRAWBERRY FESTIVAL

The Strawberry Festival is WPC's annual outreach to the Wallingford community held on the first Monday evening in June, when we invite our neighbors to share food, games, books, treasures and fellowship. Secondly, the net proceeds from the Festival support mission work that is approved each year by Session based on recommendations by the Care Council's Mission and Service Committee and the Strawberry Festival Leadership Team.

The 2025 Strawberry Festival was held on June 2nd with record crowds and the help of our many amazing volunteers. This year's proceeds benefited the following organizations:

Chester Eastside, INC: \$6607.27 (75% of net profit)

Troop 277: \$528.58 (6% of net profit)

Troop 2019: \$528.58 (6% of net profit)

Pack 228: \$264.29 (3% of net profit)

SF retains: \$880.97 (10% of net profit) for capital improvements for future Strawberry Festivals
In addition, \$679.69 from the 2024 Strawberry Festival was transferred to the general operating fund to purchase additional tables for the Fellowship hall and to cover operating expenses incurred by the Festival.

MISSION AND SERVICE

The Mission and Service Committee continues to be able to provide ongoing support for the amazing work of local and worldwide missions because of your generosity. Our church leadership faithfully includes our work in the budget and your additional gifts of money and time have made it possible for us to reach out in times of great need. Your contributions to WPC continue to support our missionaries in their varied and much-needed ministries around the world: John Stauffer and The America Team for Displaced Eritreans, Jeni Pedzinski at her new position as Director of Mission Mobilization, New Life Center Foundation in Asia, Corey Booker and the Making a Change Group in Chester, Chester Eastside, CityTeam, and the Green House Project in Chester. We spent time reviewing and revising our support as needs and conditions have changed.

- The 2025 Christ Market raised \$5,040, in support of 10 organizations and their ministries to help those in need. This is doubled with a matching gift from Mission and Service funds.
- In the Fall, M&S partnered with the Sunday School and the congregation for Socktober where socks for men and women went to Savage Sisters in Kensington. Children's socks went to Chester Eastside. We also had a last-minute clothing drive to support Savage Sisters.
- We partnered again with our music director, Lee as she hosted three "Concerts for a Cause" throughout the year. We matched donations dollar-for-dollar up to \$500 for the concerts.

STEWARDSHIP COUNCIL

Stewardship Council oversees the church's financial resources, including developing and monitoring the annual budget.



This year, Stewardship Council:

- Completed the 2025 fiscal year with slight surplus of funds.

TREASURER'S REPORT

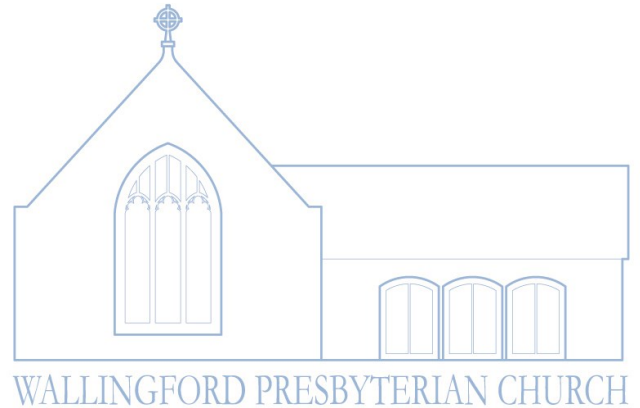
2025 Financial Highlights:

- Net Revenue adjusted to exclude non-cash unrealized gain on investments was \$51,712.
- The greater than expected surplus was the result of a \$60,000 capital gain distribution. Without the capital gain there would have been a net revenue deficit/loss of \$8,256.
- Pledge and plate offerings, WPC's key revenue source, was essentially equal to those of 2024 -- \$478,000 in 2025 compared to \$479,000 in 2024,
- Expenses were under budget by \$17,000 due to lower expenses incurred for head pastor when Pastor Francois retired in October, and lower benevolence expense. These lower expenses were offset by significantly higher expenses for building and grounds maintenance, most notably electric and gas which jumped by 15%.
- Overall asset and reserve levels declined by year end as a result of large drawdowns primarily for updates to the A Manse and repairs to the church sanctuary ceiling (about \$50,000) and the purchase and installation of audio/visual equipment (about \$38,000). These were paid from the restricted net asset funds, MEND and Memorial Funds respectively, and not the operating budget.

2026 Budget Highlights:

- Expenditures are budgeted to increase about 3% over actual expenses in 2025 and are roughly equal to 2025 budgeted expenses.
- Costs in several areas—personnel, utilities, insurance—were identified with Wallingford Coop Nursery School that could be shared more effectively which resulted in approximately \$15,000 in savings to the church.
- Staffing costs increased approximately 4% year over year. The Head of Staff was budgeted at annual level.
- Pledges to date for 2026 are \$365,364, only 71% of the \$514,000 in pledge and plate offerings required for a balanced budget.
- Rental revenue is uncertain as B manse tenants are moving from the property in February 2026 resulting in several months of vacancy.

Following the worship service, moderator the Reverend François Lacroix called the meeting to order and opened with prayer. He reminded the congregation that only members can vote. Clerk Chris Darr certified that there was a quorum.

The congregation moved to dispense with the reading of the minutes of the Annual Meetings of January 28, 2024 (found in the Annual Report). There was no new business.

Mission and Ministry. Pastor Lacroix commented on his work and the ministry of the congregation. He praised each member of WPC's excellent staff, as well as others, including the deacons, trustees, Sunday School teachers, "quiet contributors," the Wallingford Cooperative Nursery School, and his wife and WPC Congregational Wellness Nurse Cyndi Lacroix.

Clerk Chris Darr updated the congregation on the process to call a new pastor given Pastor Lacroix's retirement in the fall.

1. She said that the Mission Study Team has been hard at work gaining input from the congregation through surveys and listening sessions and has just completed their Mission Study Report. Darr thanked Ver Picher for his leadership of the Mission Study Team as well as the other members of the team: Ben Drane, Lin Floyd, Lisé Meloy, Rick Miller, David Rudd and Erin Vaccone.

2. Darr relayed that after the report is approved by Session and the Presbytery's Commission on Ministry, our new nominating committee will work to identify members to serve on the Pastor Nominating Committee (PNC). Session will call a special congregational meeting for the congregation to approve the members of the PNC.

3. The PNC will put together a "Ministry Discernment Profile" describing our church and the areas of focus for our next senior pastor; pastors will be able to view this profile and "put their names in the hat." The PNC will review information provided by pastors and interview those who appear to be a good fit. Our goal is to complete the work prior to Pastor Lacroix's retirement.

Darr added that Session and the PNC will be appreciative of the congregation's prayers and the Holy Spirit's guidance during the process.

Pastor Lacroix then turned the meeting over to Pastor Cornelius to moderate.

Pastor Cornelius highlighted that she is grateful for all of the good things happening in WPC's ministry and for her opportunity to serve. She thanked the members of the Education Council, the deacons and those who work with the children's programs.

Nominating Committee. Nominating Committee Co-Chair Ver Picher presented the following members to serve as "at large" members of the 2025 Nominating Committee: Ashley Drane, Walt Kaminski, Pat La Borie, Jenny Montague and Jim Oetinger and alternate members Carol Freidinger and Lisé Meloy. There were no nominations from the floor. The congregation voted to approve the nominees.

Picher thanked Co-Chair Kristine Mulhorn, Ken Ezzell, Pam Mattote, Lisé Meloy, Jenny Montague, Jim Oetinger, David Rudd and June Tolomeo, and alternate members Nancy Curtis and Walt Kaminski for their service on the 2024 Nominating Committee. Pastor said they were officially relieved of their duties.

The meeting of the congregation was suspended so that the meeting of the corporation could be held.

Corporation Meeting. President of the Board of Trustees Bruce Clark called the meeting to order. The Clerk certified that a quorum was present. There was no new business.

Clark referred members to the report of the Board of Trustees in the Annual report. He noted that capital projects completed in 2024 included the electronic sign and air conditioning in Fellowship Hall, and he said that 2025 will include projects in the Avondale manse. Clark thanked the scout groups for their assistance with maintaining the grounds, as well as those rotating off of the Trustees (Ken Ezzell, Roger Friedinger, Pat La Borie, Walt Kaminski and Jean Stromberg). Clark also welcomed new Trustees David Rudd (completing the unexpired term of John Tiedeck, who moved away from the area), Mike Meloy and Doug Shafer. Clark added that the Trustees welcome assistance from those with skills in areas such as electrical, plumbing, heating and air conditioning, painting, carpentry, flooring, roofing, woodworking, and gardening, particularly since the number of Trustees serving has been reduced to eight. The congregation voted to receive the report and to adjourn the Meeting of the Corporation.

The Congregational Meeting reconvened.

Treasurer's Report. Co-Treasurer Todd Darr reviewed the 2024 financials. (See Annual Report.) He noted that 2024 was positive overall from a financial standpoint and included a generous bequest from Ralph and Jean Parks.

Of note, Darr said that in 2024, WPC began realizing investment income on the income statement rather than solely recognizing it on the balance sheet (as had been done previously). This change resulted from a review of our accounting practices by the CPA firm Brinker Simpson, who said that reporting income on the income statement improves clarity and is a best practice in financial reporting. Without the Parks bequest and the recognition of investment income on the income statement, Darr said there would have been a deficit of about \$30,000. Darr noted that investment income has historically been reinvested for future growth, new initiatives, and contingencies, and it would therefore limit our future growth if we relied on investment income to cover any deficits.

Budget. Pastor Lacroix reminded the congregation that the Session approved the budget. Todd Darr then presented the budget. (See Annual Report.) There were no questions. Pastor Lacroix thanked Darr as well as Co-Treasurer Ed Mattote (who will be stepping down from the position in 2025) and Financial Secretary Michelle Hall.

Parks Bequest. Stewardship Co-Chair Helen Picher highlighted the service of long-time members Ralph and Jean Parks and their generous bequest of nearly \$95,000, received in 2024. She indicated that after the bequest was received, the Stewardship Council requested input from the councils and committees on ways to use the funds. The funds, approved by Session, were used or were set aside for: air conditioning in Fellowship Hall, the final amount needed for the electronic sign, updating the WPC website, the commissioning of a choral piece to honor the Parks, and to cover certain pastor transition costs as we search for and install a new senior pastor.

Pastoral Terms of Call for 2025. Personnel Committee Chair Helen Picher reviewed the 2025 terms of call (see Annual Report) after Pastor and Cyndi Lacroix and Pastor Cornelius left the sanctuary. She highlighted a change in the cost of benefits instituted by the Presbyterian Board of Pensions. The cost of benefits is now calculated based on the people being covered (pastor, spouse, and/or children) and the actual costs of the benefits. Previously, we paid an amount that covered a full family, regardless of who we were actually covering. This change was beneficial to WPC and resulted in a 15 percent decrease in expense for comparable benefits. Under the new formula, Pastor Cornelius' benefits are covered by WPC, but her husband's benefits are covered by his church (rather than both churches covering the full family). Pastor Cornelius' daughter is covered by her husband's church, so part of the WPC budget includes a line item for a contribution to Paoli Presbyterian Church to cover one-half of the cost of the coverage for the Cornelius' daughter. In addition, Picher noted that the budget includes a 6 percent salary increase for staff to "catch up" since salary increases since the pandemic began were lower than the cost of living (COLA).

After a motion to approve the terms of call, the congregation unanimously approved them.

Pastor and Cyndi Lacroix and Pastor Cornelius returned to the meeting and the congregation voted to receive reports of the Boards, Councils and organizations.

The congregation voted to adjourn the meeting.

Pastor Cornelius closed the meeting with prayer.
